COURSE DESCRIPTION:

Bi305 is an introduction to the prophetic literature of the Old Testament. It includes:

- A study into the role of the prophet in Ancient Israel
- A survey of the sixteen books written by the prophets of Israel
- A study into the unifying themes found through the prophetic books.

PREREQUISITE:

Bi230 - Biblical Exegetical Practices

STATEMENT OF MISSION:

- identify many of the great prophetic themes common to the prophetic books.
- demonstrate an introductory knowledge of the predictions, particularly of the Messiah, found in these 16 books and the attestment to their fulfillment in the New Testament.
- integrate the theological and ethical principles found in these books into their life and ministry.

6	BOOK REVIEW: Following the reading of "Cracking Old Testament Codes" by Sandy & Giese the student will write a 2 page or longer critical review of the text. At least one page of the review should focus on the importance of genre as presented by Sandy and Giese. A second page should review the interpretation of the various prophetic types including oracles, announcements, and apocalyptic writings. This paper is due the 11 th class day, Dec. 5 th , 2013.	20
7	EXEGETICAL STUDY (TERM PROJECT) - This will be based on one of the following passages concerning " The Coming One " (or the three main pictures of Messiah) and should be approximately five to ten pages in length: II Sam. 7:11-17 Daniel 7:13-14 Isaiah 53:1-6 See class assignment schedule for due date. Students are expected to indicate their Term Project Passage to the Course Instructor prior to the 4th class session as indicated on the class assignment schedule and to submit the completed project as specified on the class assignment schedule. The paper should include the historical setting in which the prophecy was given, an examination of the important teachings of the passage and	130
	relationship of this passage to the person and ministry of Jesus Christ. Documentation is a must. Papers not properly documented will be returned to the student (no credit). It should be 5-10 pages in length and at least 10-15 sources should be used. Only MLA style will be accepted since this is the officially accepted style for Life Pacific College. PLEASE NOTE : It is not meant to be an opinion paper so it should be based on solid research. The student should certainly be aware in the midst of doing research for this paper that all sources you might consult do not hold to an evangelical conservative theological viewpoint.	

	Therefore the student must be careful in the final conclusions he/she will draw from this research. A full bibliography of all sources used to compile the paper must also be included. The paper should be in proper and accepted term paper style and attention must be paid to grammar, spelling, form and style as well as content. Please also include a title page with pertinent information, including your name and box number. The paper should then be stapled together for presentation. Do not turn in loose pages. Of course, the content pages should be numbered. DO NOT TURN IN A PAPER WITHOUT PROOF READING THE FINAL COPY! This is a basic obligation of the writer.	
8	Oral Presentation - Each student will sign up(or be assigned) to be a part of a team covering one of the books of the Major Prophets One person will be assigned as the team leader and will be responsible for assembling and presenting the final Oral Presentation. The remaining team members will prepare a one to two-page report on the section he or she has chosen. The written reports must be given to the Team Leader on the assigned week to allow for his assembly of the final report and the team review. The Team Leader's grade will be assigned by the Course Instructor. The remaining Team Members will receive a grade that is a composite grade which is 75% based on the Team Leader's assessment of the quality of the written material and the team members' interaction and it will be 25% based on the Team Leader's Oral Presentation Grade assigned by the Course Instructor.	120

NOTES REGARDING GRADING:

- 1) Final Scores will not be rounded off, 90.99 will be a "B", etc.
- 2) Exams may be retaken if a failing grade is received. The two scores would then be averaged out and this could bring this score up to a C. The student will need to take the initiative contacting the course instructor in order to retake a failed exam. Please note that other than the retaking of a failing exam there are no other make-ups or bonus options that will impact grading. Please do the assignments as noted in the Course Syllabus, and the various reading and memorization logs. In all cases it is the student's responsibility to arrange for an exam retake within a week of the return of a graded exam.

ADDITIONAL COURSE POLICIES:

- **1. ASSIGNMENTS ARE DUE** at the beginning of class on the assigned day. Assignments may either be submitted in paper form, or be eMailed to the instructor's eMail of record but it is the student's responsibility that the eMail arrives prior to the start of class and in a format readable by the instructor¹. Unexcused late work will receive the reduction of one grade (or 10%) for each day late, including Saturdays. Late work will only be accepted in the case of illness or emergency.
 - It is the student's responsibility to take the initiative to call and inform the professor **BEFORE** such a case exists. Arrangements will be made by the course instructor at that time as to when the work will be due because of the mitigating circumstances.
- 2. If necessary, the course instructor will dismiss any student from class for rude, interruptive or other inappropriate behavior (or dress). This includes sleeping in class or doing homework in class. If noted, the professor will ask the student to leave and the student will receive an absence for that class.
- **3. ATTENDANCE POLICY:** This class is a three-unit class and scheduled for thirteen three hour class periods during the semester. A student may miss 1 session without penalty. However, for each class session missed after that there will be a reduction of one full grade. One point is given for each 10 minutes tardy. After 30 minutes, the student will be charged with a full absence. The tardy points accrue and one absence will be given for every four tardy points. Please note that it is a general policy that when a student leaves class after roll is taken, he/she will be counted absent for the entire class period. If some sudden emergency occurs that would prompt his/her exit, the student should give a note to the professor when he/she returns stating why and for how long he/she was gone from the classroom. The student should always make arrangements with another student to obtain classroom notes as exams and quizzes include classroom lecture material.
- **4. ALL CELL PHONES**, pagers, or any other type of "attention getting devices" are to be turned off before the beginning of class to avoid interfering with class time. If it is critical that you be reached then make sure that your device(s) is(are) on a QUIET setting so that the rest of class is not disturbed.
- 5. COMPUTER USAGE during class to aid in note taking and interacting with the course material is encouraged. However this time is NOT to be used for email, chatting, blogging, surfing, gaming or any other activities which might interfere with others participating in class.

8. THE ORAL PRESENTATION: - Additional Information

Detailed Team Member Information:

- 1. Team Member ONE, will receive the various written reports provided by the other team members. They will then compile the Oral presentation which should be reviewed by the other team members before its class presentation.
 - Team Member One's grade will be completely assigned by the Course Instructor based on the final Oral presentation, and its written transcript.
- 2. Team Member Two, reports on "**The Man'**" Information on the prophet himself, his background, personality, family, length of life, dates, wealth, meaning of his name in Hebrew, religious training, divine call, persecution he faced, etc. Also describe any unusual ways in which the prophet communicated. Both material drawn from Scripture as well as any traditions noted during research may be included.

 Team Member Two's grade will be 75% based on the Team Leader's assessment of the
 - Team Member Two's grade will be 75% based on the Team Leader's assessment of the quality and quantity of material provided to him for incorporation into the Oral Report. The remaining 25% will be based on the grade given to the Team Leader by the Course Instructor.
- 3. Team Member Three, reports on "**Historical Background**" Describe the political and social situations of that day, the kings who ruled during the prophet's life, the powerful foreign empires of the Near East at that time, wars, dates, cultural insights that would help us understand the message of the prophet.

 Team Member Three's grade will be 75% based on the Team Leader's assessment of the
 - quality and quantity of material provided to him for incorporation into the Oral Report. The remaining 25% will be based on the grade given to the Team Leader by the Course Instructor.
- 4. Team Member Four and higher report on "The Message" Give the major biblical truths presented by the prophet--for example: What does the prophet say about such important subjects as The Coming One, The Day of the Lord, judgment, forgiveness, the nature and the power of God, the Age to Come, etc. Also describe the spiritual problems he was trying to combat through his preaching and teaching. As class size will allow, the book will be divided into sections according to the number of people in the team. Each of the team members assigned to work on "The MESSAGE" will be assigned one of the segments of the book. Those students reporting on "The MESSAGE" will have their grade be 75% based on the Team Leader's assessment of the quality and quantity of material provided to him for

incorporation into the Oral Report. The remaining 25% will be based on the grade given to the Team Leader by the Course Instructor.

All Team Members that are preparing written material should remember to summarize their material before giving it to the Team Leader. Due to time constraints, the Team Leader will need to be selective on what to include in the final Oral Report. Thus, not everything presented to the Team Leader is guaranteed to be included in the final Oral Report.

The Final Oral Report should not exceed 30 minutes in presentation time. Prior to the Oral Presentation a written transcript should be provided to the Course Instructor along with the graded written individual reports.
